

**“Resolution No. 26/2022 of the Supervisory Board of INTER CARS S.A. of
Warsaw, dated September 28th 2022**

KRS No. 000008734

*expressing opinions on amendments to the Company's Articles of Association and on the
adoption of the consolidated text of the Company's Articles of Association by the General
Meeting*

The Supervisory Board of INTER CARS S.A. of Warsaw (the “Company”), in connection with Principle 4.7 of the Best Practice for GPW Listed Companies 2021, resolves as follows:

Whereas:

(A) On September 13th 2022, the Company’s Management Board convened an Extraordinary General Meeting of the Company for October 10th 2022, whose agenda includes, inter alia, voting on a resolution to amend the Company’s Articles of Association by adding Art. 11.11, which defines the Management Board’s obligation to provide certain information to the Supervisory Board, and modifying Art. 13 and Art. 14, which govern certain technical matters;

(B) In the Management Board’s opinion, the proposed amendments are primarily intended to ensure the consistency of the Articles of Association with the newly enacted amendments to the Commercial Companies Code under the Act Amending the Commercial Companies Code of February 9th 2022 and Certain Other Laws (Dz.U. of 2022, item 807), which comes into force on October 13th 2022. At the same time, the addition of Art. 11.11 is intended to limit the scope of the Management Board’s obligation to provide information to the Supervisory Board and to ensure that the Supervisory Board obtains only such information as it actually needs;

(C) Pursuant to Art. 16.4.3 of the Articles of Association and Art. 430.1 of the Commercial Companies Code, amending the Articles of Association requires a resolution of the Company's General Meeting;

(D) In connection with the proposed amendments to the Articles of Association, it is also necessary to pass a resolution to adopt a new consolidated text thereof; and

(E) In compliance with Principle 4.7 of the Best Practice for GPW Listed Companies 2021, the Supervisory Board issues opinions on draft resolutions placed by the Management Board on the agenda of the General Meeting.

Section 1

Now, therefore, having considered the rationales for draft resolution Nos. 3, 4 and 5 of the General Meeting included in the notice published by the Management Board on September 13th 2022 to convene an Extraordinary General Meeting of the Company for October 10th 2022, the Supervisory Board recommends that the General Meeting pass resolutions to amend the Company's Articles of Association and to adopt the consolidated text thereof, consistent with the said draft resolutions.

Section 2

This Resolution shall come into force upon its adoption.”
